# **ABOUT THE POSITION**

This position serves as the Small Sales Forester.

Duties Include:

- Develops and prepares a program for small sales of forest products. This may include commercial thinning and salvage of timber damaged by disease, insects, or wind.
- Prepares and/or participates in preparation and review of appropriate environmental analysis documents.
- Provides advice, technical support and answers questions regarding small sales.
- Develops sale packages of timber including layout, area determitation, determination of quantity to be sold (crusing), appraisal, and contract writing.
- Conducts or assist with auctions and award of contracts within delegated authority.
- Administers contracts. Inspects contractor operations to assure contract compliance.
- Conducts monitoring and completes required reporting.
- Working both indoors in an office setting and outdoors in a variety of weather situations and terrain requiring significant physical exertion such as climbing over dense vegetation in steep terrain.

This position needs someone who is self motivated with interest and abilities in leadership, communication, and teamwork.

# THE DUTY STATION

The position will be stationed in Waldport, Oregon.

Waldport is a city of approximately 2,000 residents located on US Highway 101 in southern Lincoln County, near the middle of the Oregon coast. Waldport offers small businesses such a grocery store, restaurants, gas stations, hardware and variety stores, banking institutions, and a health clinic. Waldport has miles of sandy ocean beaches, forest roads, hiking trails, wilderness areas, and a picturesque bay. This is the coast treasured by Oregonians. Waldport offers fishing, crabbing, biking, hiking, sailing, and more. For more information about the community of Waldport visit the Chamber of Commerce website: http://www.waldport-chamber.com/.

The nearest full-service community is Newport, OR located about 16 miles north of Waldport. Newport has approximately 10,000 residents and offers larger shopping opprotunities, a hospital, a variety of entertainment including a theatre and performing arts center. There are a variety of housing options in the Waldport/Newport area and within the community of Yachats 8 miles south. Prices vary, but tend to run on the high side as you near rivers and the ocean beach. Rentals are available from \$750 to \$1,100 per month, and homes are available to purchase from \$170,000 to \$250,000 or higher.

All three levels of schooling are present in the area and there is a community college campus located in Newport.

# **ABOUT THE RANGER DISTRICT:**

The 479,000 acre Central Coast Ranger District-Oregon Dunes National Recreation Area extends from Newport, OR in the north to North Bend, OR in the south; from the Pacific Ocean to the crest of the coast range mountains (just west of Corvallis and Eugene). The Siuslaw's coastal influence, ocean-forest interface, relatively young Douglas-fir forest, and cultural history make it unique. Restoration, Recreation and Partnerships are key to the Forest's program. The Forest has been a leader in stewardship contracting, with three Stewardship Groups on the district. These have been instrumental in building community connections and furthering restoration work on the National Forest System and adjacent lands using the Wyden authority.

### **ABOUT THE FOREST:**

The Siuslaw National Forest headquarters is located in Corvallis, Oregon. The headquarters is co-located with the Pacific Northwest Research Station on the campus of Oregon State Univerity. The forest lies about 20 miles west of Corvallis and encompasses a little over 600,000 acres stretching from Hebo to the north along the Pacific Coast, south to the Oregon Dunes National Recreation Area which covers 30,000 acres. The Forest lies on the east and west sides of the Oregon Coast Range with the highest point being Mary's Peak at 4,097 feet.

The forest is known for its density of great rivers and fishing (3,200 miles of perennial and 5,00 miles of intermittent streams used by 5 species of salmon), as well as abundant elk and other wildlife, tall trees and diverse forest products in a coastal rain forest environment.

There are 3 wilderness areas, covering 22,500 acres and 132 miles of hiking trails within the forest. Other recreation opportunities include beach-combing, sand dune OHV riding and

trekking, hunting, and boating/fishing in abundant coastal lakes, bays, and estuaries.

The forest is currently focusing on the following priority items: 1) Create healthy forest habitat; 2) Provide coastal recreational experiences; 3) Nurture partnerships; and 4) Restore streams and aquatic species.

The position will be stationed in **Waldport**, **Oregon**. **Applicants must apply to this location if they wish to be considered**.
