- Experience developing, delivering, and evaluating educational programs for diverse audiences utilizing a variety of educational techniques, methods, and modes

Position Summary:

The Natural Resources Extension Educator serves the people and communities of Wisconsin by addressing local, statewide and national issues, improving lives through research-based education, fostering partnerships and action, and facilitating positive impacts that support:

- Thriving individuals and families
- Effective organizations
- Healthy and vibrant communities
- Strong economies

This Natural Resources Extension Educator position will primarily serve Northwest Wisconsin, but may serve stakeholders and colleagues anywhere in the state.

The Natural Resources Extension Educator designs, promotes, administers, and supports outreach activities, community engagement, and educational programming. Develops partnerships and builds strong relationships utilizing interdisciplinary skills.

Initial programming focus will include:

- Supporting ongoing efforts to reach woodland owners with no previous management experience
- Supporting partnership efforts to create and implement an information and outreach strategy to reach the identified woodland owner audiences
- Working with the Regional Natural Resource Educators to fulfill funding partners requirements around outreach and education
- Facilitating working sessions where local citizens and community decision-makers weigh alternative natural resources conservation strategies

This position will have a primary program affiliation in the Land and Water Program within the Natural Resources Institute.

The Natural Resources Extension Educator is an employee of the UW-Madison Division of Extension, a member of the Natural Resources Institute and will be assigned to the Natural Resource Educator Program as their primary program.

Principal duties:

Programming (60%)

- Provide support for multi-disciplinary, integrated natural resources programming that addresses local and statewide needs
- Plan, implement and evaluate educational programs directed at community needs on issues relating to the purpose of the position
- Develop or adapt and implement culturally-relevant, research-based educational programming to meet identified needs and opportunities and evaluate programming to improve effectiveness, inform future design and demonstrate value
- Expand access by reaching and engaging diverse audiences and ensuring full access to programs, facilities, and educational services
- Evaluate and report on programming by utilizing established tools and processes to inform future program design, improve effectiveness and demonstrate value

Collaboration & Relationships (30%)

- Participate in and provide support for multi-stakeholder collaborations
- Act as a coordinator and educational liaison to build coalitions and facilitate communication between state and federal agencies, organizations, local governments, and citizens
- Develop and maintain respectful working relationships
- Collaborate with statewide colleagues within and across organizational structures to develop and adapt standardized and relevant programming
- Promote Cooperative Extension and its programs to build greater access, visibility and value

Administrative & Programmatic Accountability (10%)

- The Outreach Specialist/NRE is accountable to the Natural Resources Education Program Directors for all matters related to performance and day-to-day work activities. The NRE is also accountable to the Land and Water Program Manager and the Natural Resources Institute Director
- Creates a plan that identifies appropriate audiences, describes the programming to meet their needs, connects to larger program objectives of Cooperative Extension and assesses programming effectiveness
- Submits reports that meet the requirements, policies, and established practices of Cooperative Extension and partners, including federal Civil Rights requirements
