- Educational background with emphasis on pre-hospital care or related field with demonstrated knowledge, skills, and abilities to perform essential functions.
- One (1) year experience performing EMS in a pre-hospital setting.
- Experience using computers, radios, reporting platforms, database and spreadsheet software.
- Valid Oregon OR National Registry EMT license or reciprocity within 90 days of hire.
- Valid Oregon driver's license or ability to obtain one within 90 days of hire.
- Good attitude with the desire to serve.
