ABOUT SYRCL

The South Yuba River Citizens League (SYRCL – *pronounced circle*) was founded in 1983 by grassroots activists determined to protect the South Yuba River from dams. Ultimately, SYRCL won permanent protections for 39 miles of the South Yuba River under California's Wild and Scenic Rivers Act. Today, SYRCL is the central hub of community activism to protect, restore, and celebrate the Yuba River watershed. With 38 years of achievements, 3,500 members and volunteers, SYRCL is doing great things for the Yuba watershed. SYRCL is a leader in the Sierra headwaters for addressing statewide and regional issues – challenging new dams, recovering endangered species, addressing climate change and drought, water security and water quality. Together, we are extending our powerful coalition from the summit to the sea.

POSITION SUMMARY

The Forest Conservation Program Manager leads and envisions SYRCL's forest conservation work throughout the Yuba River watershed. SYRCL's forest health work accelerated in 2019 and thus has grown considerably in the past few years. The program aims to 1) improve forest health and forest resiliency throughout the watershed 2) engage diverse stakeholders throughout the Yuba River watershed to promote and implement forest health projects, 3) partner with local educational institutions for workforce development opportunities and 4) raise funds through collaborative grant requests and alternative funding streams.

The Forest Conservation Program Manager will work to meet the above goals as currently envisioned while also defining a larger forest conservation program for the organization.

This is a full time, exempt position. Main work hours will be scheduled during normal business hours (Monday-Friday 9 am -5 pm) and evening and weekend work may be required.

RESPONSIBILITIES

The Forest Conservation Program Manager will provide leadership, strategic and science-based recommendations, direct supervision of one or more employees, proactive fundraising and grant writing, while implementing forest restoration projects. This requires a significant amount of stakeholder engagement and knowledge in the fields of forest ecology or forestry as well as managerial and fundraising experience and contractor management. The successful candidate will help set and advance SYRCL's advocacy priorities including:

- ..Continue to build sustainable and diverse Forest Conservation program within SYRCL's Watershed Science department that works towards research collaborations, volunteer activities, and thousands of acres of restoration projects.
- · Lead and support fundraising efforts, including grant writing and leveraging resources, necessary to identify and implement new projects.
- Seek out opportunities for cross-disciplinary collaboration within SYRCL, leveraging existing program areas. Contract and grant management, including developing, negotiating, awarding, and administering requests for proposals, contracts, budgets, and reports.
- Become familiar with traditional ecological knowledge principles and contemporary practices in indigenous communities in the Sierra Nevada. Support forest conservation projects that promote inclusion and indigenous land management.
- Develop, support, and oversee implementation of ecological forest restoration projects, possibly including commercial and non-commercial thinning, reforestation, prescribed fire, and invasive weed control to meet ecological and project goals.
- Engage in project planning, including selection of treatment type (prescribed fire, mechanical thinning, hand thinning, non-commercial and pre-commercial thinning, etc.) and intensity.
- Secure permits and approvals and ensure compliance with NEPA and CEQA. Supervise contractors, including planning surveyors, forestry consultants, and field crews.
- Lead participation in the North Yuba Forest Partnership and maintain SYRCL as a lead partner. Delegate and oversee participation as appropriate.

QUALIFICATIONS:

Required Skills:

- Bachelor's Degree in forest ecology, forestry, silviculture, natural resources management, or a closely related field. Advanced degree preferred.
- A minimum of five years of relevant experience.
- Knowledge of forest ecology for conifer and mixed forests.
- Proven grant writing and project management experience including ensuring that awarded grants are tracked to make certain completion of deliverables, reporting, billing
 and invoicing.
- Facilitation experience or training.
- Proficient with GIS and mapping.
- Demonstrated experience in creative problem-solving, opportunity development, effectively leveraging talent across diverse teams, and developing novel approaches with high-impact outcomes.
- Ability to build consensus, develop effective coalitions and collaborate with diverse interests.
- Team player and ability to interact effectively and respectfully with people from different cultures and experiences and those who live in nearby communities.
- Effective communication skills necessary to develop and maintain lasting partnerships with government, agency, and community representatives, among others.
- Demonstrates initiative, is conscientious, and provides follow-through on areas of responsibility.
- Positive, self-motivated, and quick learning performer highly valued. This position requires confidentiality, and a sense of humor is a must.
- Possession of a registered and insured personal vehicle, and a valid California Driver's License.
