GENERAL DESCRIPTION:

The Wyoming Game and Fish Department seeks a Data Scientist. This position provides spatial data analysis, data management, workflow development, and statistical modelling in service to wildlife managers and the Wildlife Division. Primary responsibilities include assistance with updating species-monitoring programs, improving rigor and application of relevant research, and ensuring Department access to clean, useable datasets. While the incumbent should be able to work on any taxa, many of the job duties are associated with nongame species. Work products from the Data Scientist will enhance the Department's use of sound science and data in wildlife management. The position is part of the Department's Science, Research and Analytical Support Unit. Applicants should have a strong analytical skill set and a keen interest in wildlife management. The position will be based at the Cheyenne Headquarters Office (preferred) or at an approved regional office.

• Data management and workflow development. Develop workflows to manage field and spatial data, particularly for sage grouse and other Species of Greatest Conservation

Need. Work with Department personnel to ensure that data are properly uploaded, cleaned and backed up, thereby guaranteeing future access. Assist Department personnel with data retrieval and interpretation.

- Study design and data analysis. Review study designs for research and monitoring projects, with a focus on Species of Greatest Conservation Need. Work with project proponents to make sure that study designs and analyses yield defensible answers to management questions. Analyze wildlife data to support Division needs, and to assist with the implementation of the State Wildlife Action Plan. Develop visuals, publications and other deliverables to disseminate results. Participate in field data collection activities to assist with Department research and monitoring projects.
- New science application. Work with the Unit supervisor, Unit staff, Programs and Regions to implement updated analytical and wildlife monitoring techniques. Help the Division and the Director's Office remain current on emerging science. Develop and review new analytical approaches to address pressing management needs
