The Payette National Forest is seeking candidates to fill a GS-0460-11/12 Forest Silviculturist position. **We are seeking candidates for both the permanent, full-time position, as well as a possible up-to 120 day detail/temporary promotional appointment.** Interested applicants should contact Michael Feiger, Payette National Forest Acting Natural Resources Staff Officer at 208-634-0707 or michael.feiger@usda.gov. This position serves in the Natural Resources Staff area in the Payette National Forest Supervisor's Office, McCall, Idaho. The position serves as program leader with responsibility for the development and of silvicultural plans and programs. The silviculture program includes silviculturist certification, stand prescriptions, reforestation, timber stand improvement, tree improvement/genetics, as well as participation, consultation and review in NEPA planning for vegetation projects.

The Forest Silviculturist coordinates with other resource areas to integrate multiple resource benefits into vegetation management projects, and serves to develop and manage partnerships that enhance capacity to accomplish forest health and ecological restoration projects. The Payette National Forest is currently engaged with the Weiser-Little Salmon Headwaters Collaborative Forest Landscape Restoration Program (CFLRP), which would be a focus of this position's collaborative efforts. Coupled with that work, furthering the application of Good Neighbor Authority work in partnership with the State of Idaho will also be a focus of this position, as well as the Shared Stewardship agreement the Agency has entered into with the State. A brief summary of duties and responsibilities for this position include, but not limited to:

- Provides technical support and leadership to line and staff officers, and District/SO personnel in the interpretation and implementation of National Forest System, Region, and Forest-wide policy and direction, as it pertains to forest vegetation management;
- Provides leadership and coordination between the Forest, Region 4 Idaho-Wyoming Pod, and the Regional Office in vegetation management, in support of the planning and implementation of projects contributing to Flagship Targets in vegetation and natural fuels treatments, as well as support to the CFLR and Shared Stewardship Programs;
- Develop and maintain effective relationships with external partners, including other Federal and State land management partners, the Payette Forest Coalition, Rocky Mountain Research Station, and others, in the sharing of technical expertise and support of forest management actions;

- Provides leadership and technical guidance to District silviculture staffs. This includes respective reforestation, timber stand improvement (TSI), forest inventory, and vegetation and fuels management planning and implementation supporting the Payette National Forest's Forest Plan implementation;
- Leads the update and maintenance of Forest wide vegetation databases and information, including updating the Vegetation Classification, Mapping, and Quantitative Inventory (VCMQ), Forest Service Activities Tracking System (FACTS) and other databases that support Forest Plan and project-level planning efforts and target and accomplishment reporting;
- Provides leadership, guidance and technical expertise to District Silviculture and Timber Staffs through training opportunities and exposure to Forest Products Modernization Strategy and its effective implementation on the Payette National Forest;
- Leads the development, management, and tracking of the Silviculture program budget, and as a delegated member for the Forest Budget Committee, support the development of the Forest Program of Work and budget for the Payette National Forest;

The work of this position is usually performed in an office setting; however occasional field work may be required that entails considerable walking, bending or climbing. The selected candidate must be certified as a Silviculturist or be able to obtain certification within three years of appointment.

ABOUT THE PAYETTE NATIONAL FOREST

The Payette National Forest contains some of Idaho's most beautiful and diverse country. Located north of Boise in west-central Idaho, the 2.3 million acre forest extends 100 miles west to east, from Hells Canyon to the Middle Fork of the Salmon River in the Frank Church River of No Return Wilderness. The forest stretches 70 miles between the Main Salmon River to the north and the Weiser River to the south. There are five Ranger Districts, approximately 200 permanent employees, and over 150 temporary seasonal employees during the summer field season. The current Forest priorities are:

- **Landscape Restoration** focusing on working with collaborative groups to accomplish landscape-scale restoration in the Weiser River and Little Salmon watersheds, which will improve watershed function, habitat for wildlife, recreational opportunities, and reduce hazardous fuels, as well as provide local employment through stewardship contracting.
- **Recreation Management** supporting developed and dispersed recreation opportunities during both summer and winter seasons across the Forest, stewardship of the Payette's portion of the Frank Church River of No Return Wilderness, and providing outstanding public service.
- **Rangeland Management** managing for sustainable rangeland resources such as soil, water and native vegetation while administering livestock grazing permits and monitoring to maintain separation between domestic sheep and bighorn sheep during the grazing season.
- **Minerals Management** of significant minerals projects and the numerous smaller minerals development projects.
- **Wildland Fire Preparedness** including training and preparedness to manage wildland fire incidents on the Forest and across the country.

McCall, located in Valley County, lies 90 miles north of Boise on State Highway 55. Sitting at 5,000 feet, it occupies the south shore of beautiful Payette Lake. The population swells from 3,200 to 10-20,000 in the summer during the peak of tourist season and in the winter during the annual Winter Carnival celebration. Total snowfall is over 10 feet, allowing McCall to boast some of the best winter recreation in the state, with snowmobiling, sledding, Nordic and downhill skiing. Brundage and Tamarack Resorts are within a short drive. Summer is shorter than at lower elevations but is ideal, with daytime temperatures in the 70-80s, and a few days in the 90s. Payette Lake provides plenty of swimming, boating, and fishing opportunities in the summer; a state park and adjacent Forest lands provide ample hiking, running and biking trails. Sunshine is common in all seasons. Access to the expansive and remote Frank Church-River of No Return Wilderness Area and Hells Canyon National Recreation Area and Wilderness are located nearby.

McCall is a full-service community that fills most needs. It has a regional hospital, an integrative health clinic, dentists, chiropractors, and optometrists. McCall also has several service stations, two grocery stores, motels, banks, lumber yards, a variety of restaurants, coffee shops, a wide variety of shopping, daycare centers (including a Forest-sponsored daycare), a public and a private golf course and an airport. Numerous churches are located in the surrounding area.

The community has an excellent grade school, new middle school, a high school that serves both Donnelly and McCall, and an alternative school. Numerous extra-curricular activities and electives are available. There is a strong winter sports program, with both downhill and Nordic after school ski programs. The Payette National Forest Supervisor's Office, and McCall and Krassel Ranger District offices are located in McCall. Several Fire and Aviation facilities and programs are also located in McCall including the Payette Fire Cache, Payette Dispatch Center, McCall Smokejumper Base, McCall Helibase and the McCall Airtanker Base. Average housing cost is in the \$250,000 to \$350,000 range; as of 2017, the average median home price, according to the Mountain Central Association of Realtors, was \$314,013 and in nearby Donnelly was \$187,250. Condos or small apartments are available for rent from \$700 to \$1,200/month. There is limited government housing available in McCall.
