Join our team here on the Malheur National Forest and be a part of a good organization that cares about its people and the land they manage. The Malheur National Forest encompasses 1.7 million acres of wilderness, rangeland, and general forest in the majestic Blue Mountains of Eastern Oregon. The Malheur National Forest is at the center of a nationally recognized effort that is doubling the scale of restoration in Eastern Oregon. If you are looking for an opportunity to do groundbreaking nationally recognized work, we are certain you will find our approach to leadership in natural resource management refreshing.

Engineering - Civil engineering programs on the Malheur National Forest provide management of infrastructure and ecological restoration projects located across approximately 1.7 million acres of Forest Service lands. The team includes 18 permanent staff that are accountable for the development, construction, operations, and maintenance of over 9,000 miles of roads, 130 buildings, 25 bridges, and a dam.

<u>Range</u>- The range program on the Malheur National Forest is one of the largest in Region 6 with approximately 111 grazing allotments, 145,000 permitted cattle AUM's, and one wild horse territory. District and Forest staff work closely with resource professionals on the forest, with permittees, and with external partners to implement a wholistic approach to rangeland management through monitoring and implementation in riparian areas and uplands.

Hydrology - The Malheur National Forest hydrology program is highly integrated with the fisheries program on the Forest and plays a critical role in the implementation of watershed, stream, and wetland monitoring and restoration activities. Additionally, the hydrologists participate in interdisciplinary teams to collaborate across programs to achieve resource objectives. Strong internal and external collaboration is integral to the success of the aquatics program. The Malheur National Forest has an incredible network of partners that we collaborate with to implement restoration projects across the forest, ridge top to ridge top.

<u>Heritage</u> - The Malheur National Forest Heritage Program manages various cultural resources across the Forest. This includes supporting NEPA and NHPA compliance needed to maintain and enhance Forest resources. The Heritage Program works with Forest staff and partners to identify methods to protect, preserve, and utilize these cultural resources. In addition, the Heritage Program looks for opportunities to share these resources with the public through Passport in Time projects, local presentations and events, and professional conferences.
