



Job Announcement – Registered Professional Forester

We are currently seeking qualified Registered Professional Foresters to join our team at all office locations. Work will be diverse and is anticipated to range from participation and administration of large federal and private industrial contracts, management of nonindustrial ranch properties, grant funded fuel reduction projects, timber inventories, as well as fuel reduction work on small private parcels. Qualifications for this position include the following:

- Must be a California Registered Professional Forester
- Must be physically and mentally able to work long hours productively in harsh terrain under adverse weather conditions as well as operate effectively in an office environment
- Must possess a valid driver license and remain eligible to operate company vehicles, including trucks and all-terrain vehicles
- Must have a clean driver record and successfully pass a background check and drug test
- Possess a working knowledge of timber inventory and silviculture practices as well as logging, road construction and reforestation operations
- Must be apt at use of standard computer software such as MS Word and Excel; working knowledge of ArcGIS PRO preferred
- Must be an excellent communicator, both verbally and in written form
